Individual Parenting Consultations: November 4, 18, and 25

- You are welcome to drop by for a 30-minutes free consultation with Cameray's Parent Educator to discuss your concerns regarding parenting and children (aged 6 to 18) development concerns.
 Parenting consultations cover, but are not limited to:
 - Identifying families strengthen their skills to help create positive bonding
 - Addressing behavioral challenges exhibited by tweens and teens
 - Exploring ways to enhance effective communication
 - 🖶 Understanding age-appropriate developmental milestones
 - Cultivating self-worth and self-compassion
 - Seeking alternate ways in how to raise a good human
 - Boundary setting
 - Supporting tweens and teens to develop emotional and mental well-being

My Tween and Me (eight sessions): Fridays, November 1, 8, 15, 22, 29 (continuing Dec 6,13, 20), 5:30 pm to 7:30 pm, at Cameray, 2038 Rosser Avenue, Burnaby.

My Tween and Me is developed, owned and copyrighted by the BC Council for Families, for delivery by practitioners and agencies across Canada.

My Tween and Me (MTM) provides parents/caregivers and their tweens with knowledge, tools and support as the child transitions to adolescence. MTM strengthens parent-child communication and supports parents with building positive relationship with their child.

This group is for parents/caregivers and their **children aged 7 through 12.** Parents/caregivers are expected to attend two sessions with their child(ren) to cultivate bonding and enhance mutual understanding.

Throughout the eight sessions, we will:

- Enhance knowledge of tween growth and development
- Build effective communication skills for both parents and tweens
- Promote positive youth development
- Foster strong family and community relationships

This group is in-person. A light dinner will be provided. Childminding is available.
